

**THE SHELL<sup>®</sup> SEMA SWEEPSTAKES**  
**OFFICIAL RULES**

**OPEN TO ELIGIBLE LEGAL RESIDENTS OF THE 50 UNITED STATES/  
DISTRICT OF COLUMBIA/CANADA WHO ARE AT LEAST 18 YEARS AND  
WHO ARE REGISTERED ATTENDEES OF THE 2016 SEMA SHOW.**

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A  
PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF  
WINNING.**

**1. ELIGIBILITY:** "The Shell<sup>®</sup> SEMA Sweepstakes" ("Sweepstakes") is open only to individuals who are registered attendees of the 2016 SEMA show in Las Vegas, Nevada (the "Show") and are legal residents of, and residing within, the fifty (50) United States (including the District of Columbia) or Canada and are at least eighteen (18) years old (or the legal age of majority in his or her province of legal residence, whichever is greater) at the time of entry ("Entrant(s)"). Employees of Pennzoil Quaker State Company d/b/a SOPUS Products ("Sponsor"), and its parent, affiliates and subsidiaries, participating advertising and Sweepstakes agencies, including but not limited to Mercury Promotion & Fulfillment, Specialty Equipment Market Association ("SEMA"), direct competitors of Sponsor, and those entities involved in the preparation of materials for, administration and/or execution of this Sweepstakes (collectively "Sweepstakes Entities") and their immediate family members (spouse, parent, child or sibling) and/or those living in the same household (whether or not related) are ineligible.

**2. SWEEPSTAKES OVERVIEW:**

PT on Friday, November 4, 2016 ("Sweepstakes Period") at the Shell SEMA Experience located outside the main entrance, #60005 (the "Booth"). The Booth closes at approximately 5:00 P.M. PT each day during the Sweepstakes Period (except November 4, 2016).
- b. Each day during the Sweepstakes Period, Sponsor (or its authorized representative), will conduct daily drawings on or about 12:00 P.M. PT, 2:00 P.M. PT and 4:00 P.M. PT on Tuesday, November 1, Wednesday, November 2 and Thursday, November 3, 2016 (the "Daily Drawing(s)") to randomly select potential Sweepstakes winners ("Potential Winner(s)") from among all of the eligible entries received prior to each Daily Drawing during the Sweepstakes Period.

- c. Sponsor (or its authorized representative), will conduct the "Special Drawings" on Thursday, November 3, 2016 at 4:00 p.m. PT and Friday, November 4, 2016 at 2:00 p.m. PT from among all of the eligible entries received prior to each Special Drawing during the Sweepstakes Period.

**3. HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible Entrant must visit the Booth during the hours of operation, locate one (1) of the six (6) Sweepstakes tablets and complete and submit the registration form including his/her complete first and last name (no initials unless initials are his/her first or last name), valid e-mail address, and confirming that he/she is at least 18 years old (or the legal age of majority in their province of legal residence, whichever is greater) and agrees to these Official Rules. All hats, gift cards, coolers and the helmet are "Minor Prizes." All hats, gift cards and the helmet must be picked up by the winners at the Booth no later than 3:30 P.M. PT on November 4, 2016.

- i. ## **6. IMPORTANT INFORMATION FOR THE WINNERS OF A 4 POST LIFT BY DIRECT-LIFT®:**

- i. All lift shipments will be delivered via a common carrier ("Carrier") such as Old Dominion or Yellow Freight on an enclosed semi-trailer approximately 53 foot in length.
- ii. Residential deliveries cannot be made if the Carrier cannot drive a 50 foot semi in the neighborhood due to local ordinances or because of obstacles preventing this size of vehicle from safely maneuvering through the neighborhood.
- iii. The driver is not responsible for unloading the equipment.
- iv. To unload the lift a Winner will require a forklift, backhoe, or similar equipment that has the capacity to lift and move 3000 pounds.
- v. Due to equipment size, lift-gate deliveries are not possible.

Freight Carriers will not allow a 4-Post Lift winner to remove the lift one piece at a time; the complete lift must be removed all at once.

## **7. IMPORTANT INFORMATION FOR THE WINNERS OF A LIVE NATION**

INDIVIDUALS COVENANT NOT TO SUE ANY RELEASED PARTY OR CAUSE THEM TO BE SUED REGARDING ANY MATTER RELEASED ABOVE; AND FURTHER COVENANT NOT TO DISAFFIRM, LIMIT OR RESCIND THIS RELEASE. Submission to the Régie is only for the purpose of helping the parties reach a settlement.

Subject to the jurisdiction of the Régie, Sponsor reserves the right to terminate, suspend or modify the Promotion. In the event of any discrepancy or inconsistency, between the English-language version and the French language version of these Official Rules, the English version shall prevail and govern.
